

NEW BUSINESS

Approval VACS Projects: Brandon Blevins presented the Feb 2024 VACS CEF Ranking Sheet. Discussion included that funding currently available would not start to pay for the two highest ranking projects but will cover the third highest ranking project's cost share. Andy Smith made a motion to approve contract # 25-24-0020 in the amount of \$4,930. Kelly Gilmer seconded the motion and the motion carried.

Small Farm Ag Community Outreach Event: Siobhan Nishida asked for approval of funding to be spent on lunch for the Small Farm Ag Community Outreach Event. Discussion included advertising for the event and asking for an RSVP for people interested in staying for a provided lunch. Funding will come out of the Education Adult Outreach Programs Budget. Kelly Gilmer made a motion to spend up to \$500 on the lunch for the Program. Jason Bush seconded the motion and the motion carried.

Proposed Landfill Discussion: The BOD and Staff discussed the role of the CVSWCD with reference to the proposed landfill in Russell County. Zac Ketron asked for the Education Committee to meet and report to the BOD at the March Meeting with suggestions of parameters.


